Richfield Stake record book entitled "Record of Richfield Branch of the Church..." (see Feb 1876), apparently written in early 1873. The first few pages of this record (through 1871) is focused on Richfield settlement, not the entire county. Then it restarts with a retrospective history of the whole valley through 1877, followed by stake minutes. All of this record may have been written or copied much later. For example, the entry for May 1 1873 says "some of these [settlers] became notable in the history of the county."

1861

Settlement at Gunnison is first on the Sevier River

1863

Summer: George A. Smith sends a scouting party from Provo to Sevier Valley who decide to settle, leading to a kerfuffle with Orson Hyde, who claims sole authority to direct settlement in the area, corroborated by the first presidency

October: Hyde sends first settlers to Salina from Sanpete [MH] December: Glenn's Cove settled, led by Robert Wilson Glenn²

1864

January 6: first settlers in Warm Springs [**Richfield**], from Sanpete valley, led by Albert Lewis (but not a branch per se)³

January 8: first settlers at South Bend [Monroe], led by Moses Gifford⁴

January 11: First settlers in (Glenwood) led by Robert W. Glenn.(PE?) Spring: first settlers at Jericho [Joseph]

Feb 19: Orson Hyde and Bp. H.H. Kearns (Gunnison) visit Salina and "ratified the appointment of Peter Rasmussen as presiding authority."⁵ The settlers had elected him earlier in the month. Spring: Albert Lewis resigns leadership of **Richfield**, 6 settlers choose Nelson Higgins to preside, and he chooses counselors⁷

May 2: Salina Branch organized with Peter Rasmussen as Bishop (no counselors)

May 12: Peter Rasmussen ordained Bishop of Salina Ward by Orson Hyde (EH, MH, LDSBE 4:552) conflicts with May 24

May 31: Orson Hyde reports on a trip to the "new settlements on the Sevier." Visits "Salt Creek or **Salina**," sets apart Peter Rasmussen as President (24th); "Glencoe" [**Glenwood**], calls James Wareham as president (20th); Alma [**Monroe**], calls Wiley P. Allred as president (21st); Mary's Vale (no settlers yet); Circle Valley "at the forks of the Sevier." confirms Wm Allred as President; Jericho [**Joseph**] (only one or two families, no branch); **Richfield**, set apart Nelson Higgins as president (23rd)

August 2: BY and HCK: "Elder Nelson Higgins has this day been set apart to preside at **70** and has also been ordained to the bishopric, more particularly to officiate as Bishop in Richfield and the region adjacent." ⁹

Nov 3: Orson Hyde reports that he has called 25 families from Moroni to settle in Alma [**Monroe**], and 20 families from Ephraim to settle in Circle Valley [Circleville], plans to call more from Mt. Pleasant and Manti.¹⁰

Nov 12: Orson Hyde reports on visit to nascent Sevier settlements. ¹¹ Mentions developments at Richfield, Alma [Monroe], Circleville ("our upper settlement on the Sevier"), Selina, and Glennwood

November: Orson Hyde dictates the name Glenwood

Orson Hyde frequently mentions traveling with "Bishop Bryan." Who is this? [Bishop of Nephi?]

1865

January 9: Letter from "Nelson Higgins Bishop" to the Territorial Legislature

January: Sevier County organized, including Wm Morrison as probate judge

February: Orson Hyde has authorized a new settlement at "Rocky Ford," 10 miles south of Salina (Prattville?)¹²

Spring: Orson Hyde ordains James Wareham as president of Glennwood¹³

Spring: Nelson Higgins called as bishop of Richfield with counselors, divided into four wards with a teacher over each.¹⁴

April: first Indian attacks in Richfield, starting of Black Hawk War.

May 31: Report from Fillmore mentions "Bishop Nelson Higgins" 15

September 8: A. Milton Musser (with Franklin D. Richards) visits Salina, "Peter Rasmussen Actg. Bp.," Glennwood, "James Wareham presiding," Richfield, "N. Nelson Higgins Bishop," Alma, "Wiley P. Allred presiding" ("sometimes called South Bend")¹⁶

Sep 10: Musser visits Marysvale, "Jno. Beal presiding," and Circleville, "William Jackson Allred presiding" ¹⁷

Sept 12: Franklin D. Richards reports on preparations for war. "The most of settlements, pretty strong in numbers, are nevertheless much exposed. Their names are as follows: Salina, 15 miles from Gunnison with about 35 families. 16 miles further up is Glennwood with about 40 families. Then 6 miles nearly west on west side of river is Richfield with about 110 families. This is the county seat of Sevier Co. Alma [Monroe] comes next on east side of river 14 miles from Richfield, some 70 families." mp:700342

Sept 13: More detailed version of Franklin D. Richards report. 19 Visits to:

- Salina (9/8), Presiding Elder Peter Rasmussen
- Glenwood (9/8), Presiding Elder James Wareham
- Richfield (9/9), Presiding Elder Nelson Higgins
- Alma (9/9), Presiding Elder Wiley P. Allred

Nov 19: Orson Hyde reports on visit to Sevier Valley.²⁰ Due to threats of Indian issues, some families are leaving Alma; President Wiley Allred wants to be released, so Hyde calls Frederick Olson to replace him

April-May: Reports to PB Edward Hunter from James Wareham—"Glenn Wood" "Ward," Bishop N. Higgins—Richfield "Ward," President Andrew Hendriksen—Marysvale, F. Olsen—Alma, William I. Allred—Circleville, all part of "Sanpete."²¹

April 18: BY writes Frederick Olsen, Alma about a branch matter. 22 So it isn't abandoned yet April 28: First Presidency writes "President Orson Hyde and the Bishops and Saints in Sanpete, Sevier and Piute Counties" about settlement abandonment procedures and other wartime policy.²³

April 29: Alma residents arrive in Richfield²⁴ Apparently they later returned April: Salina abandoned, move to Gunnison; Glenwood, Alma, and Marysvale partially abandoned, families move to Richfield while men build forts²⁵ June 15: Richfield begins building a fort²⁶

1867

Abraham Shaw presiding in Glenwood

21 Feb: BY writes "Bishop Nelson Higgins, Richfield" 27

22 Feb: BY writes Orson Hyde, suggesting that the people fort up, but that Richfield, Glenwood, and Alma should be maintained (for now)²⁸

Late February: Orson Hyde visits Sevier Valley with Gunnison Bishop Kearnes to advise them on defending themselves (and read BY's letter): Glennwood (which will move to a more defensible location "on the open plain"). Alma, and Richfield.²⁹

April 1: BY telegraphs Orson Hyde "Richfield, Alma and Glenwood move to Gunnison or elsewhere." 30

April 5: Bishop Kearns of Gunnison writes Bishop Higgins of Richfield, suggesting that they temporarily relocate in Gunnison when they abandon Richfield.³¹

April 17-18: Richfield abandoned³²

Nov 13: BY writes Nelson Higgins (who appears to be living in Pond Town) about the possibility of resettling along the Sevier River.³³

1868

March 17: BY writes George Crismon, authorizing him to lead a company to resettle in Sevier County.³⁴

March 28: BY writes Orson Hyde, instructing him to take charge of organizing the effort to resettle Sevier County.³⁵

April: a party from Sanpete attempts to resettle Sevier Valley, but is attached by Indians³⁶ April 25: In first of a series of published Church directories, Orson Hyde is "County President" of Sanpete, Sevier, and Piute Counties, but no wards or branches in Sevier County are listed.³⁷ mp:700394

Feb 1: status of "wards" in central Utah includes: Gunnison 93 families (Joseph Horne on a "mission" there), Fayette (Warm Creek) 11 families. Nowhere else in Sevier Valley mentioned.³⁸

April: Glenwood resettled, let by Abraham Shaw (PE?)³⁹

August 2: Brigham Young authorizes William Morrison (county probate judge) to resettle Sevier Valley, but does not explicitly give him any presiding authority.⁴⁰

September 25: Resettlers meet in Spring City to plan efforts⁴¹

Fall: First resettlers arrive in Richfield. Orson Hyde had appointed Wm. Morrison to preside over them (branch?).⁴²

December 18: Wm. Morrison sustained by Richfield settlers as president (of county? Stake? Branch? ward?) with counselors.⁴³

Orson Hyde does not seem to have much to do with the resettled Sevier County; he never mentions these settlements in his frequent letters to Brigham Young during 1870-1874

1871

January 24: Sevier County government reorganized by settlers in Richfield.⁴⁴

February: Bishop Nelson Higgins returns to Richfield (having lived in Pond Town [Salem] and Nephi), resumes his duties according to Brigham Young's instructions⁴⁵

February 28: Abraham Shaw retires from leading Glenwood, Archibald W. Buchanan chosen to preside with counselors⁴⁶ (called a branch by May)

March 5: Richfield settlers meet, approve Nelson Higgins as Bishop of Richfield⁴⁷ "Br. Wm Morrison had hitherto acted as president" Further organized on the 7th and 9th. Four teacher-led wards also reinstated. No congregation type is mentioned.

March: Alma resettled as Monroe; (acting?) Bishop Moses Gifford with counselors⁴⁸ Summer: first settlers in Omni Point/Thompson Springs [Annabella].[MH] Sometime later a ward(?) was organized under bishop Hugh Lisonbee.[KWJ8-83N]

Spring: **Salina** resettled under Peter Rasmussen.⁴⁹ MH says he was presiding again with counselors, 1) John Johnson

March 27: William Morrison reports to Brigham Young on resettlement efforts in Sevier County. Fig. 8 Richfield has 40 families, 70 men; Glenwood 20 families, 40-50 men led by Archibald Buchanan; Alma 30 men and a few families, led by Moses Gifford; Salina about the same, led by John Jansan [counselor?], although Peter Rasumussen has recently returned. Morrison asks Pres. Young for a more complete priesthood organization.

April 25: Report from Richfield says "Bro. Nelson Higgins, who, before was appointed and acted as Bishop... has again been chosen to preside here..." ⁵¹

July 26: William Morrison writes a very apologetic letter to Brigham Young about his personal leadership of the resettlement of Sevier Valley, mentioning Richfield by name.⁵² He seems to have been reprimanded for overestimating his authority given by the letter. *It may be that he had been reprimanded for making himself Stake President*.

August: Richfield Bishop's court, Morrison refuses to acknowledge the bishop or other leaders "as his superiors" (apparently, the real issue is Morrison claiming land that the original settlers were now returning and reclaiming)⁵³

28 August: BY writes "Mr. Peder Rasmussen, Salina" about a tithing matter, suggesting that he is acting as a branch president.⁵⁴

Oct 1: Richfield "Ward Clerk" replaced.⁵⁵ First contemporary primary source reference to it as a ward

Oct 11: Bishop Nelson Higgins of Richfield, Sevier Co., reports on "his diocese." *Diocese=Sevier County or Richfield Ward?*

November 3: first settlers in Cove [Sevier]⁵⁷

1872

3 Jan: BY writes "Elder Archibald W. Buchanan, Glenwood" about tithing in "your branch."⁵⁸ 17 Feb: difficulty between Richfield and Central City (Inverury) about competing canal routes⁵⁹ Bishop Higgins says he had appointed Wm A Stewart as "head teacher of Central City" who had

"promised to obey the council of the authorities of Richfield." The bishop's council drops Stewart.

22 Feb: BY writes "Bishop N. Higgins, Richfield," mentions that his letter to Morrison was never intended as "giving him any authority to preside," but he cannot speak for anything Orson Hyde may have said.

Spring: Joseph resettled, Moses Gifford (Monroe President) appoints James Hale to preside at the Cove area (Sevier/Joseph)⁶¹

21 March: Richfield bishop's council considers the issue of William Morrison. He will not accept charges "for claiming the presidency of Sevier County without proper license" and "for defying the priesthood as organized in this place [the bishopric]" Morrison says "he never claimed the presidency of Sevier County" and that "Pres. B. Young had said that Bp. Higgins had no authority to cut him off." Higgins claims otherwise, and the meeting ends with not resolution. May 7: First Presidency calls Joseph A. Young (son of Brigham Young) to "travel in the settlements in Sevier County, and adjacent country between Gunnison and Kanab, to instruct

settlements in Sevier County, and adjacent country between Gunnison and Kanab, to instruct the people ... and to counsel with the local presiding officers in the general management and direction of affairs in their settlements." Sounds like more of an advisory role than a presidential one, probably similar to what the apostles are doing in other counties.

May 18: Orson Hyde and Joseph A. Young meet with the local priesthood, Young presiding.⁶³ Higgins-Morrison feud is debated. Young is sustained as "President of the settlements of Sevier Valley," (making the issue moot) *Morrison becomes Young's clerk*

May 19: Orson Hyde introduces Joseph A. Young to the Sevier saints⁶⁴

July 20: First stake priesthood meeting minutes.⁶⁵ Pres. Young "called for reports from the various **wards**:"

- Richfield, Bp. Higgins, 150 families, four teachers' wards, school
- Monroe, Counselor Jones, 80 families, 4 teachers; wards, school
- Glenwood, acting Bishop A. Buchanan, 75 families, 4 teachers wards, school

Helaman Pratt chosen as president of Glenwood Branch. LDSBE 4:612 says he was acting bishop

Oct 31: BY suggests that Nelson Higgins resign as bishop of Richfield in favor of "young and efficient bishops." ⁶⁷

Nov 11: Nelson Higgins writes BY to resign.⁶⁸

Nov 19: BY acknowledges receipt of resignation of Nelson Higgins as "President and Bishop of Richfield," asks J.A. Young to appoint a replacement.⁶⁹

Nov 19: BY asks "Prest. Jos. A. Young" to find a replacement for Higgins. 70

Dec 7: Priesthood meeting, wards represented: Richfield, Bp Higgins; Monroe, Bp Giffords, Glenwood, Bp H. Pratt; Joseph City, Bro. Isaacson [branch]⁷¹

1873

January 25: At a priesthood meeting, Bishop Helaman Pratt of Glenwood "gave a sad account of affairs there." Pres. Young "proposed to organize a temporary High Council for the benefit of Glenwood and nominated A. Buchanan, H.C. Jacobs, Henry Russell, Walter Jones, Bp. Higgins, & N.M. Peterson, and Pres. Jos. A Young for the 7th." This was almost certainly not intended to be a stake organization as many histories suggest, but an ad hoc independent group to adjudicate the difficulties in Glenwood.

March 8: At priesthood mtg, "Prest Young recommended establishing small settlements thickly throughout the country as a source of strength in case of Indian hostilities." First mention of "the new place called **Prattville**." It is possible that Prattville was formed as a resolution of Glenwood issues, which may have included Bishop Helaman Pratt.

May 21: "Joseph A. Young, President of that district."83

May 24: "Sevier Stake of Zion" organized by apostles Orson Pratt and John Taylor: Joseph A. Young president, A.K. Thurber First Counselor; only 8 high councilmen called; presidents of MP quorums.⁸⁴ Young mentions that he had started to organize the stake on his own, but decided to wait for general authority, and asks the visiting apostles (Orson Pratt and John Taylor) to start from scratch.

Gunnison Bishop Joseph Horne remembers "Gunnison and its Branches were added to Sevier Stake of Zion" ⁸⁵ *Presumably, this would be branches at Fayette, Mayfield, and maybe Willow Creek [Axtell].*

May 24: Archibald Todd Oldroyd ordained bishop of Glenwood (LDSBE 2:682)

May 27: New list of wards/branches. Same as April 8, except: **Monroe**, J.T. Lisenbee⁸⁶ July 17: JA Young reports on **Salina**; Peter Rasmussen, President and Acting Bishop since 1864 has resigned after some trouble with the members. Suggests Franklin Spencer as a replacement, Rasmussen is called to lead a mission to Grass Valley (Koosharem).⁸⁷

August 25: First Presidency writes Franklin Spencer in Manti: "You are hereby instructed to take charge of the **Salina** Branch of the Church under the Direction of Elder Jos. A. Young." Sep 5: Priesthood meeting Includes Bp. Jos S. Horne (Gunnison), Bp. Jas T. Lisonbee (Monroe), Bp. HD Lisonbee (Annabella), Bp. Iver Isaacson (Joseph). Franklin Spencer ordained and set apart as new bishop of Salina, Archibald T. Oldroyd "had been elected" as new bishop of Glenwood replacing Bro. Wilson, Peter Rasmussen to lead Grass Valley settlement/mission.

Sep 29: Joseph A. Young visits **Fayette**, where they complain about being part of Gunnison; a separate branch is organized, Pres. John Bartholemew.⁹¹ *Are Fayette and Gunnison part of Sevier Stake?*

Fall: some Richfield members receive permission from Joseph A. Young to make a new settlement on U.O. farmland "up the ditch"; he suggests the name Elsinore after the city in Denmark. 92

Oct 9: Joseph A. Young visits **Joseph**, presiding elder Isachson is accused of something but exonerated.⁹³

Oct 23: James or Joseph K. Rogers called to preside at Prattsville, as Helaman Pratt has been called to Mexico

March 25: First settlers from Provo arrive in Willow Bend [Aurora].[MH] At some point, branch (dependent on Salina Ward) organized with Daniel Morgan as Presiding Elder. MH says this was in 1880.

Spring: Vermillion settled, PE Peter Gottfredson, a dependent branch of Glenwood Spring: First settlers at the Red Mound [Redmond] [MH] It was never considered part of Salina Ward

July 11: Conference in Orderville with Bishop Howard O. Spencer, Joseph A. Young (Sevier President), John R. Young (Kanab president?). Joseph A. appears to be presiding. ¹⁰¹ August 5: Joseph A. Young dies; not replaced as president, but counselors and high council appears to have continued to act.

Albert K. Thurber acted as "President pro tem of the Sevier Stake until 1877" (LDSBE 1:520) 31 August: BY writes "Bishop J.T. Lisenbee, Monroe" 102

13 October: BY writes "Elders Thurber and Seegmiller" (presidency counselors) about matters of "the United Order in Sevier District." In several documents like this, they seem to avoid calling it a Stake.

23 October: in stake leadership meeting, BY letter is read, "copies were ordered to be sent to all presidents of branches in this stake of Zion." Presumably, it is accepted that they are temporarily in charge. In this and subsequent meetings, Thurber frequently refers to all the settlements collectively as "branches." Joseph K.
