Gray: needs to be verified in primary sources.

1847

James Brown stops at Miles Goodyear's cabin on his way to California to meet the Mormon Battalion.

November 25: Church buys Goodyear's Fort. James Brown starts to settle his and other families there. ¹

1848

The Nascent settlement is called Brownsville.²

1849

February 16: As the Twelve is creating all the wards in Salt Lake Valley, they decide to organize a ward at "the Brown Settlement" as one of three wards north of GSLC (the others being North Canyon/Bountiful and North Cottonwood/Farmington).³ Mp:700828

March 25: In the Bishops' quorum meeting in Salt Lake, "James Brown was ordained bishop of **Weber River Ward**, and Joseph L. Robinson bishop of North Cottonwood Wood."⁴

September 3: Brigham Young visits and explores the area around the fort: "They decided the town should be laid out on South side of Ogden's Creek at the point of bench land so they might take out the water out of the Weber & Ogden rivers for irrigating & other conveniences." ⁵

1850

January 31: Weber County created by Deseret Assembly

March 4: BY writes "the Saints at Weber Branch" via Elder Ezra Taft Benson, who is coming to organize them.⁶

March 5: **Weber Branch** organized, with Lorin Farr as president, possibly covering all of Weber County. JHC says "Branch was organized on the Weber River."⁷

March 6: ward established in same area, with Isaac Clark as bishop.⁸ *Probably just a branch with both president and bishop.*

August 28: Brigham Young visits, lays out the plan of the city of Ogden, counsels saints to settle in the city, not in the country.⁹

Lorin Farr builds a fort north of the Ogden River, which is for a couple years the center of the settlement.[Mound Fort MH]

First settlers in Riverdale area

1851

January 26: Meeting with Brigham Young and other leaders "for the purpose of organizing a presidency & high council and bishops for that place." "Lorin Farr was chosen president of **Weber Branch**" [branch-stake], with counselors and a high council. Isaac Clark ordained bishop of the **South Ward** [south of Ogden River (Brown's Fort)], Erastus Bingham bishop of the **North Ward** [north of Ogden River (Farr's Fort)], each with counselors.¹⁰

February: Government of Ogden City and Weber County organized

April 7: In the Fifth General Epistle, the First Presidency says "In January we ... organized a <u>stake</u> of Zion at Ogden City, by appointing a Presidency, High Council and Bishops: Loren Farr is president of that stake." ¹¹

April 22: PB Edward Hunter writes to outlying bishops, about "your ward or district", including "Isaac Clark and Erastus Bingham" ¹²

Summer: Ogden city surveyed and residents begin moving to their lots

September 4: Lorin Farr reports from "the Stake of Zion at Ogden City, Weber County," with presidency, high council, two bishoprics¹³ He also calls it a "branch."

April 3: "A Report of the Stake of Zion in Weeber County, called Weeber Stake." ¹⁷ mp:700812 622 members [not itemized into wards]. Lists Lorin Farr, president of the stake, counselors and high council, and:

- Isaac Clark, Bishop of the first ward
- Erastus Bingham, Bishop of the second ward
- Lewis Hardy, President of the Weeber Kanion Branch [East Weber]
- Thomas Dunn, President of Ogden Hole Branch [North Ogden]
- Joseph Lish, President of Willow Creek Branch [Willard]

April 9: "Abiah Wadsworth of **East Weber Branch (Uintah)**, Weber County was ordained a Bishop" by Edward Hunter¹⁸

October 1-5: Statistical Reports from wards. 19 Same as summary report below, except:

- Ogden Hole Branch (North Ogden), Pres Thomas Dunn, 409 members
- East Weber Branch (Uintah), Bishop Abiah Wadsworth

December 22: [North Ogden] Branch organized by Pres. Lorin Farr, Pres. Thomas Dunn²² Includes future Pleasant View [MH]

28 December: List of members and wards in Utah includes Ogden City Ward.²³ December 31: Bishops' statistical report lists the following wards for Weber area: East Weber [Uintah] (Bp. Abiah Wadsworth), Ogden (Bp. Erastus Bingham), Willow Creek [Willard] (Bp. Chas. W. Hubbard²⁴

1853

Feb 21: "This is to certify that Thomas Dunn has been ordained a Bishop in the Church of Jesus Christ of Latter day Saints for the **north/forth ward of Ogden City**, Weber County. Done in my office. Brigham Young" several secondary sources like JHC transcribe it as "fourth ward," but this isn't chronologically possible. Looks a lot like "forth." North Ogden Ward according to North Ogden MH. 26 By October 8th, he is the bishop of the **Third Ward**.

Feb 21: Thomas Dunn was ordained a bishop for the fourth ward of Ogden City²⁷ It appears that this minutes book was a later transcript/compilation by someone, possibly Andrew Jenson, so this might also be a mistranscription

March 4: North Ogden Ward organized, Bishop Thomas Dunn²⁸

April 9: General Bishops meeting includes Bishop Thomas Dunn, "Ogden Hole Ward" 29

Mound Fort and Bingham's Fort built, the latter becoming the center of the north ward³⁰ July: Meetings [Branch?] at Mound Fort, PE David Moore³¹

August 25-27: Wilford Woodruff visits the Weber settlements to finalize the location of the fort (later the site of Ogden) "on the south side of the River in the midst of the farming lands" ³²

30 Nov-3 Dec: Wilford Woodruff visits **South Weber**, Bishop Kington; "**North Weber**" (Uintah), Bishop Wadsworth; **Ogden**; **Bingham's Fort** [Ogden 2nd Ward], Bishop Bingham; **Ogden Hole** [North Ogden], Bishop Thomas Dunn⁴³

1855

Jan 16: At the bishops meeting are Bishop Dunn "of the 3rd Ward in Ogden" and Bishop Bingham of the "2nd Ward Ogden," which has "7 to 800 inhabitants" 44

6 April: statistical report for Ogden 2nd Ward, Bishop Erastus Bingham, 650 total members. ⁴⁵ This is on a standard printed form including "ward" and "bishop," so these terms are standard by then, at least in the minds of general Church leaders.

7 Apr: General bishops meeting includes "Country" Bishops Dunn [North Ogden], Bingham [Ogden 2nd], J.S. Browning [Ogden 1st], Kington [South Weber], Wadsworth [Uintah]. 46 14-23 May: David Pettigrew (prez. HP Quorum, Salt Lake Stake?) visits Bingham's Fort, Bishop Bingham; Bishop Thomas Dunn (north of Bingham's Fort?); Ogden City, Capt. James Brown, Bishop Browning; upper fort on Weber River [East Weber], Bishop Wardsworth; lower fort on Weber [South Weber], Bishop Kingston. 47

July 17: BY writes "Bishop Dunn, Ogden Hole:" "It is my mind that the brethren who are located at Ogden Hole should build a fort such as will answer to make a settlement there,... Ogden being too inconvenient and remote to you." Apparently, the early settlers believed the North Ogden Canyon to be "Ogden's Hole" from trapping lore, later realizing that it was the upper valley.

Most residents of Bingham's Fort and Mound Fort move to Ogden, remaining settlers in Bingham's Fort part of Slaterville Branch (Pres. Thomas Richardson) [Lynne MH][EH]

1856

20 Jan: Elders Quorum organized in [North Ogden], mentions Bishop Dunn⁵²

Feb 2: Home Mission Quarterly Conference at Ogden 3rd Ward [North Ogden?]. Missionaries J.W. Johnson and William Gibson present, along with President Farr and Bishop West. mentions "Bishop Dunn" ⁵³

March 19: announcement of marriage "in North Ogden Ward" performed by "Bishop Thomas Dunn."⁵⁴

June 1: Three (not four) Wards created, apparently unrelated to earlier numbered wards: ⁵⁵ [CC]

- 1st/Bench Ward, Bishop Erastus Bingham, who had recently moved from the fort to the Ogden Bench. Embraced all of the Saints who had settled on the Ogden Bench. ⁵⁶ In early 1877, the boundaries, which appear to be unchanged, are west to the brow of the bench, east to the mountains, north to Ogden River or the brow of the bench, and south to "Bunker" [probably Canfield] Creek
- 2nd Ward, Bp. James G. - 3rd Ward, Bp. Chauncey W. West; likely west to the Weber River, east to the brow of the bench, south to 4th Street, north uncertain, maybe Ogden River (Lynne sources say Bingham's Fort was attached to Slaterville) [Ogden 3rd MH does not give boundaries]
- 4th Ward, Bp. Nils C. Flygare [Hanson]/Thomas Deemer [Hunter] [can't be Flygare, he wasn't even in America yet, probably confused as he became bishop of 4th Ward in 1877]; possibly future West Weber?? Did it even exist? Deemer=Dunn??

7 Oct: General bishops meeting has representatives from wards including East Weber, Ogden City, North Ogden.⁵⁸

8 October: Edward Hunter and counselors rebaptize and reconfirm several bishops, ⁵⁹ including:

- Chauncey W. West, bishop of Ogden
- Erastus Bingham, bishop of Ogden City
- Thomas Dunn, bishop of Ogden Hole

October 10: Lorin Farr mentions "several wards in this city (that is all but Bishop Dunn's ward)," suggests Edward Bunker to replace Bishop Browning and that West take charge of the storehouse (pres. Bishop??)⁶⁰

October 13: BY's response to Farr: "I wish you to take charge and general supervision of the tithing office in Ogden City...I have counselled Bishop Hunter and his counselors to ordain Bro. March 11: BY responds to "President Farr:" "we will send some of the Twelve to organize the Branches you mention, and also to determine on the propriety of organizing the East and South Weber Branches into one Ward." 116 Do they ever come?

August 11: The first missionaries of the New Organization, Edmund C. Briggs and Alexander McCord, arrive in GSLC and meet with Brigham Young. 117 This does not give them enough time to cause enough tumult in Ogden to cause the reorganization.

August 25: Brigham Young, speaking in Ogden, "dismissed all the bishops" 118

August 25: Brigham Young, speaking in Brigham City and Ogden, admonishes the saints for selling their grain (apparently to miners in Montana; he had just given the same speech in Logan and Brigham City), "not to sell their wheat for less than two dollars a bushel for their flour for less than six dollars a hundred. He chastised the Bishops for neglect of duty, and for doing things which they had not been commanded to do." 119 This appears to be the immediate cause of the ward consolidation, but what exactly are they doing that wrong? Perhaps the wards are competing against each other to sell grain to speculators to resell in Montana, which is driving the price down.

August 25: Brigham Young announces plan to combine all wards into one and restyle them as districts. Some sources say the reorganization took place on this date, but better sources indicate that this was done in separate ward conferences

August 27: Bishop West returns from British Mission (with Brigham Young Jr)¹²¹

September 18: Brigham Young announces the reorganization in an open letter. 122 "We have appointed Br. Chauncey W. West to act as Bishop for all the settlements and inhabitants in Weber County, and that we hereby release all other Bishops in said county... the inhabitants in each settlement are hereby permitted to elect a president, which Presidents will superintend Church affairs in their several localities, and will assist Bishop West in his Bishopric."

September 20: 2nd Ward reorganized as 2nd District, Pres. Lester Herrick¹²³

September 20: North Ogden Ward reorganized as a district by Pres. Farr and Bishop West; Pres. Henry Holmes replaces Bp. Thomas Dunn (called on a mission to Bear Lake Valley)¹²⁴ His sustaining mentions "some few who voted contrary & some who were inclined to the

doctrines of Little Joseph whom Bro. Holmes had opposed a few weeks previously," suggesting that the recently arrived New Organization missionaries are getting some traction here.

October: Bishop West: Meeting to try some suspected of being "inclined to the doctrines of what is called little Joseph." ¹²⁵ Is this concern is the primary cause for the reorganization? It seems to be starting at the same time.

- May 15: First meeting of district in the Hooper area, President Gilbert Belknap who had previously been appointed by Pres. Richards and Bp. West. He is sustained along with counselors. [MH]
- May 21: Richards and "Prest Farr" visit "East Weber" 176
- May 23: Richards and "Prest Farr" hold meetings in Plain City 177
- May 25: Richards, "Prest Farr" and "Bp West" meet with district presidents along the Utah Central Railroad grade 178
- May 30: Richards meets Gilbert Belknap about securing preemption ownership of the town lots at "Muskrat" (Hooper). Then Richards and Bishop West to go West Weber District (Pres. Peter? [Archibald] McFarlane). 179 A petition had been submitted to divide it, but Richards convinces them not to. By this point, Richards is working directly with Bishop West, and President Farr seems to be less important. But is he officially stake president yet?
- June 17: "The name of Deseret Station on the UPRR has been changed to that of Uinta" 180 Presumably, this the modern Uintah, but there is no other reference to Deseret, and the district continues to be called East Weber after this.

Jan 6: List of Presiding Elders and Bishops, same as October 1874.²⁶⁶

Jan 9: "Elder David Garner of N. Ogden called [FD Richards] for counsel about ordaining some brethren in his District" ²⁶⁷ Counselors or priesthood?

Jan 24: "David Garner, Acting President" of **North Ogden** calls his own counselors. ²⁶⁸ On Jan 30, "stake authorities and FD Richards" disapproves of this practice, and calls C.H. Wheelock to replace him as president.

Jan 29: FD Richards visits with "Elders Henry Holmes and Sidney Stevens about the presidency of North Ogden Branch." ²⁶⁹

Jan 31: FD Richards visits North Ogden. ²⁷⁰ "the crowded audience requested me by vote to appoint a president for them as they had been without one since ex-President Holmes went on his mission to Arizona. I appointed Cyrus H. Wheelock and he was accepted by a unanimous vote, not one dissenting."

Feb 9: mentions "Pres't F.A. Brown of 1st District." 271

March 9: FD Richards and Bishop Herrick visit Harrisville, "Hot Spring District" [???], and North Ogden, "having seen and heard what the brethren told us about the boundaries of these 3 districts, in order to enable the county court to judge of the propriety of granting the boundaries asked for by the Hot Spring petitioners." ²⁷² It sounds like "Hot Spring" (Farr West?) wants to be made a new district; this appears to be a civil matter, but they often are aligned.

March 22: Gilbert Belnap (Hooper Pres.) recently returned from his mission. 273

March 28: **North Ogden** occasionally calls itself a ward.²⁷⁴ *This may be an incorrect assumption, as this record is written later*

April 24: Meeting of the "officers of the United Order from the various districts comprising this Stake of Zion. The work is progressing slowly in several of the branches." ²⁷⁵ Note the equivalence of district and branch.

March 16: **Ogden 1st District** redivides its teachers' districts (from 10 to 17), giving the ward boundaries in the process (map in book)²⁹⁴ It includes all of Ogden east of the bench rim and north of "Bunker Creek" (Canfield), probably south of Ogden River or the brow of the bench May 23: High Council meeting.²⁹⁵ So it has been meeting since at least 1871 May 26-28: Stake Conference, **Weber Stake** is "more completely" organized.²⁹⁶ David H. 

May 28: "The Three districts in Ogden City was divided into four wards, part of the second district was attached to the 1st and 3rd wards, and the remaining portion was called the second ward, with Main St the East boundary line to Burch Creek, thence to the river, then north to 5th St, then east to Main St." 300

Fourth Ward created from the Second District. [Ogden 4th MH] This is not correct, it was actually the 1st District. "extended North to the Ogden River, East to the mountains, south to 8th St (now 28th Street) and west to the brow of the hill till 27th Street, then west down [???] street (now Jefferson) to 26th then west to Adam ??? Prez Street (Adams Avenue) then along said aven to Ogden River" [MH] *This was likely the boundary *after* Dec 1878, given the boundary at 8th*.

June 6: Bishops counselors sustained and set apart by stake presidency and FDR for 3rd and 4th wards. ³⁰⁴

July 20-21: Stake Conference³¹⁵ Not many details, except mentioning a report of "Uintah, by Bishop Ira N. Spaulding" Uintah MH and LDS Biographical Encyclopedia says that its bishopric was ordained at this time

Dec 4: Stake counselors meet with John Taylor in SLC to discuss plans for redivision of Ogden City wards suggested by the Twelve, which is opposed by 1st Ward Bishop Brown. "cuts off all of Ogden City south of eighth [28th] street and makes of it one ward and changed the other wards back to their old lines."³¹⁶

Dec 7: Priesthood meeting; Stake Pres. Peery presiding and 3 apostles in attendance. 317 Announces the redivision of Ogden drawn up by a committee appointed by the Twelve, But 1st Ward Bishop Brown still opposes it.
